Attorney Ko, Eun Young is a specialist in criminal cases, especially in responding to police investigations, with extensive investigation experience as a former police investigation team leader. She joined the police force through a special recruitment for lawyers and served for eight years in the frontline investigation departments, handling various intellectual, economic, cyber, sexual, and violent crimes.

Her notable casework includes: △ Investment fraud and related unregistered investment schemes, △ A multi-billion won fraud and embezzlement case involving Merge Plus, △ An industrial technology leakage case involving core massage device technology, △ Copyright and trademark violations involving the famous "Hanokjip" restaurant, △ Mass lease fraud cases, △ Voice phishing criminal organization and electronic financial transaction violations, △ Fraud and embezzlement related to cryptocurrency, △ Corruption in personnel hiring at the Seodaemun District Office in Seoul, △ Pharmaceutical company kickback cases, △ Invalidation of redevelopment association chairman election, △ Hundreds of billions of won in fraud and embezzlement of clan assets, △ Medical malpractice cases involving the death of a patient at a university hospital, △ Rape and drug-related cases.

While serving in the police force, Attorney Ko was recognized as the "Best Investigator" at the Seodaemun Police Station (in 2018), received the National Best Investigation Review Commissioner commendation from the Commissioner General of the Korean National Police Agency (in 2021), and was awarded commendations and incentive awards from the Commissioner of the Seoul Metropolitan Police Agency for outstanding investigations (in 2020, 2021, and 2023). Her team was also selected as the best investigative team in the field of intellectual crime (in 2022). Since the second half of 2023, she has been handling cases in the Criminal Group at our firm.
